The **Licensed Therapist** for the **Intensive Home-Based Treatment (IHBT)** program provides services to individuals 11-21 years of age with a dual diagnosis of mental illness and substance abuse disorders and/or developmental disorders and/or mental illness.

The therapist must possess excellent assessment and crisis intervention skills and demonstrate the ability to collaborate effectively across multiple systems in our community.

### **Essential Job Functions / Responsibilities**

- Provide assessment & DSM-V diagnosing, treatment planning, education, and individual counseling.
- Place clients in the most appropriate treatment modality.
- Orient new clients to the agency's program.
- Provide crisis intervention, counseling, case management and discharge planning.
- Document the findings, treatment, and clinical outcomes.
- Monitor and provide interventions to reduce psychiatric symptoms.
- Linkage with appropriate resources on behalf of clients.
- Strong teamwork.
- All other duties as assigned.

### **Competencies**

- Expertise in family counseling/education.

- Strong knowledge of adolescent growth and development.
- Experience in Case management.
- Facilitator in group therapy and education.

### **Requirements**

- CPR/First Aid certification preferred.
- Non-Violent Crisis Intervention training preferred.
- Recognizes signs of abuse and neglect of minors.
- Knowledge of HIPAA, AoD and Federal Confidentiality Law.
- Commitment to professional growth.

### **Minimum Qualifications**

- **Master's Degree in Counseling or Social Work** with licensure by the Ohio Board of Counselors, Social Workers, and Marriage and Family Therapists as a LPC, LPCC, LPCC-S, LSW, LISW, or LISW-S.
- **One year of experience** working as a counselor. (If working with adolescents, one year of experience with adolescents.)
- Must be **fluent in written and spoken English**.
- Must have the ability to **be flexible and work in a variety of settings** (homes, neighborhoods, service systems, etc.) and be available, as needed.
- **Knowledge of community resources** is a plus.
- **Valid Ohio driver's license, proof of auto insurance, and use of a personal vehicle.**
